Previously Clabon held a relevant interest in National Hire pursuant to section 608(3)(a) of the Corporations Act being a relevant interest held through a body corporate (Australian Capital Equity Pty Ltd) in which its voting power exceeds 20%. As a result of the implementation of the scheme, Australian Capital Equity Pty Ltd has ceased to control the registered holder of the relevant shares (WesTrac Pty Ltd) for the purposes of section 608(3)(b) of the Corporations Act. 

DIRECTIONS
